CHARGE II: VIOLATION OF THE UCMJ, ARTICLE 118

THE SPECIFICATION: In that Specialist (E-4) Adam C. Winfield, U.S. Army, did, at or near Forward Operating Base Ramrod, Afghanistan, on or about 2 May 2010, with premeditation, murder a male of apparent Afghan descent by means of throwing a grenade at him and shooting him with firearms.

CHARGE III: VIOLATION OF THE UCMJ, ARTICLE 128

THE SPECIFICATION: In that Specialist (E-4) Adam C. Winfield, U.S. Army, did, at or near Forward Operating Base Ramrod, Afghanistan, between on or about 1 March 2010 and on or about 31 March 2010, commit an assault upon three males of apparent Afghan descent by shooting at them with a dangerous weapon, to wit: a loaded firearm.

CHARGE IV: VIOLATION OF THE UCMJ, ARTICLE 112a

THE SPECIFICATION: In that Specialist (E-4) Adam C. Winfield, U.S. Army, did, at or near Forward Operating Base Ramrod, Afghanistan, on divers occasions between on or about 1 September 2009 and on or about 11 May 2010, wrongfully use hashish a Schedule I controlled substance while receiving special pay under 37 U.S.C. Section 310.
