6. CURTIS EUGENE FORBES, DOB 07/18/57, was interviewed by Special Agent Smith and Columbus Police Department Asst. Chief Robert Jones on September 29, 1980 at the Columbus Police Department. FORBES had contacted Chief Jones on the previous evening (September 28, 1980) and at that time Jones requested that FORBES come to the Police Department for the purpose of making arrangements for FORBES' polygraph examination.

FORBES showed up at the agreed upon time and was advised that arrangements had been made for FORBES to take a polygraph examination in Madison at the Wisconsin State Crime Laboratory at 10:00AM on October 1, 1980. FORBES agreed that he would accompany Chief Jones from Columbus to Madison for the purpose of taking the polygraph examination. FORBES was then asked a few questions concerning his whereabouts since March 13, 1980. FORBES stated substantially as follows:

FORBES indicates that sometime during the latter part of May or the first part of June he returned to the Columbus, Wisconsin area. He states that for a while he lived out at the farm where his brother, MICHAEL FORBES, resides. He said that approximately three weeks ago he moved in with his girlfriend, DEBRA ATTLESON, who is living with her parents at Route #1, Randolph. According to FORBES, he has been working on construction jobs for both himself and for/with RANDY ZANDER.

According to FORBES, he and DEBBIE ATTLESON are to be married on October 18, 1980 at the Lutheran Church in Doylestown. A reception is scheduled to follow at the Eagles Club in Beaver Dam.

FORBES indicated that on March 13, 1980 he left the Columbus area for personal reasons. He stated that the police were accusing him or were considering him as a suspect in the death of MARILYN MC INTYRE, that he had many unpaid bills that were "catching up with him" and that he had just broken up with his girlfriend, DEBRA ATTLESON. FORBES indicated that he flew from Chicago to New Orleans, Louisiana where he proceeded to enjoy life for a while. He said that he then travelled to the Jacksonville, Florida - St. Augustine, Florida area and worked on a shrimp troller for a while. He said that while in Florida he had been in an automobile accident while a passenger in the automobile of a friend of his. He stated that his chin received some cuts and explained that as being the reason for his growing a full beard. He said that he left Florida and returned to Columbus, Wisconsin.
