LORI HEFT, DOB 09/28/58, was interviewed on 02/17/81 by S/A Smith and Columbia Police Department Assistant Chief Robert Jones. Mrs. HEFT was interviewed for any additional information that she might be able to provide concerning this investigation. Mrs. HEFT offered substantially the following information:

Mrs. HEFT indicated that she is presently living with her boyfriend, KIM HINEY. She states that she can be reached through her sister, TAMMY STEWART, who lives on _____ in Columbus, phone _____

According to Mrs. HEFT, she saw CURTIS FORBES shortly before Christmas. She states that FORBES and his brother DOUGLAS FORBES and her brother MARVIN DILLEY came over to talk. She believed that they came over looking for her other brother RICKY. She stated that her brother RICKY was seldom there and could not understand why they would come there looking for him.

She indicated that her brother, MARVIN, did babysit for her approximately 4-5 times when she lived at her old address in Fall River. She said that CURTIS FORBES and his brother, DOUGLAS FORBES, would come over to visit MARVIN while MARVIN was babysitting.

She said that on Sunday night prior to MARILYN MCINTYRE's death, FORBES came over to her house some time between 12:30 p.m. and midnight. She stated that she was home alone at the time because her then boyfriend was taking the babysitter home. She indicated that on one occasion on that evening FORBES followed her into the kitchen and tried to kiss her. She said that her oldest daughter got in between them and started pushing FORBES away. She indicated that FORBES was there for approximately 10-15 minutes.

She stated that, while FORBES was gone (in Florida), she had occasion to run into DEBRA ATTLESON in a bar in Columbus. She stated that she talked with DEBBIE and apologized for apparently getting CURT FORBES into trouble. She stated that DEBBIE told her, "We all know why he came over to your house." She stated that DEBRA went on to say that CURTIS FORBES left because of his conflicting stories. DEBRA told HEFT, "It's not your fault. You just told the truth. He made his own problems." She stated that DEBRA told her that CURTIS would never come back to the Columbus area. HEFT stated that DEBRA told her that FORBES told the police that he was there at DEBRA's by 2:30, but that FORBES never got there until 4:30 a.m. DEBRA stated that FORBES could not come up with a story to match what everyone else was saying was the truth.
